This is your Limited Warranty on Advanced Protection Products International, Inc.'s Paint Protection, Fabric Protection and/or Leather & Vinyl Protection – which has/have been professionally applied to your vehicle. This Limited Warranty is hereby offered to you upon proof of application.

Advanced Protection Products International, Inc. ("APPI"), 17732 Highland Road, #G-158, Baton Rouge, LA 70810, 1-866-366-3774, the warrantor, is responsible for providing the protection and administering the benefits under this Limited Warranty.

#### COVERAGE

To be eligible, vehicle must have less than 15,000 miles, within one (1) year of in-service date, and must have the application professionally applied within 45 days after purchase of the product.

Advanced Protection Products International, Inc. warrants for a period of five (5) years on a new vehicle and three (3) years on a pre-owned vehicle to the owner of the vehicle identified on the application, who has received a professional application of a Platinum Finish Automotive Surface Protection Product, the following in regards to:

1. Platinum Finish Paint Protection: The original painted exterior finish will retain its gloss and color. Should the OEM painted surface of this vehicle treated with Paint Protection fade, oxidize, or lose its gloss from exposure to the sun, weather-induced acid rain, or hard water etching, during the warranty period, APPI will repair originally treated areas free of charge.
2. Platinum Finish Fabric Protection: The treated fabric will be protected against accidental spills and stains. APPI will repair original treated areas free or charge.
3. Platinum Finish Leather & Vinyl Protection: The leather and vinyl surfaces are guarantees to maintain their shine and luster. APPI will repair original treated areas free of charge.

**LIMITATIONS OF COVERAGE**

This Limited Warranty does not apply to:

1. Commercial Vehicles (vehicles designed, sold or used 50% of the time for commercial purposes), or recreational vehicles (any vehicle over 18 feet in length)
2. Paint damage caused by collision, accident, fire, hail, surface rust, stone abrasions, peeling or chipping, scratching, scraping, pitting, flaking, or over spray.
3. Paint damage caused by unreasonable use, abuse, misuse, vandalism or neglect.
4. Paint damage on repaired, repainted or otherwise altered or modified surfaces.
5. Paint damage caused by manufacturer's defects or defects covered by manufacturer's warranty.
6. Any paint other than the original painted surface.
7. Treated areas damaged by unreasonable use, abuse, misuse, acts of God, vandalism or neglect.
8. Any finish, fabric, leather or vinyl that is not damaged
9. Any surface that is not treated with Platinum Finish Paint Protection, Platinum Finish Fabric Protection and/or Platinum Finish Leather & Vinyl Protection.
10. Advanced Protection Products International, Inc. is not responsible for exact paint matching or undamaged areas or matching or repairing undamaged surfaces.
11. This Limited Warranty does not provide rental car allowance or any form or rental car reimbursement.
12. The registered customer may transfer this limited warranty at the time of vehicle resale, subject to a \$25.00 transfer fee paid to Advanced Protection Products International, Inc. within 15 days of the vehicle resale date. Copies of the new registered title and bill of sale must be included with the transfer request.

**OWNER'S RESPONSIBILITIES**

To keep this warranty effective, any vehicle treated with Platinum Finish Paint Protection should be maintained by regular cleaning/washing. Any vehicle treated with Platinum Finish Fabric Protection and/or Platinum Finish Leather & Vinyl Protection should have all solid matter or spilled liquid removed from the protected surface as soon as reasonably possible. Blot up remaining liquid using a clean colorfast towel or other absorbent cloths. Do not rub. Repeat until all liquid has been removed. If there are stubborn stains remaining, contact Advanced Protection Products International, Inc. at 1-866-336-3774.

**HOW TO FILE A CLAIM**

If Paint/Fabric/Vinyl or Leather damage occurs while this Limited Warranty is in effect, you must notify Advanced Protection Products International, Inc. of your claim within thirty (30) days of the appearance of any covered damage. Failure to do so will void the Limited Warranty coverage for this claim. An Advanced Protection Products International, Inc. representative will contact you within (5) Business days of above receipt of claim information to arrange for a vehicle inspection and, if covered, repair service. You are responsible for delivering the vehicle at your expense to the designated place for inspection and service. **Any repairs made to your vehicle without first being approved by Advanced Protection Products International, Inc. will not be covered by this Limited Warranty.**

#### **Advanced Protection Products International Inc.'s RESPONSIBILITIES**

Advanced Protection Products International, Inc. will pay the total cost of repair to the damaged portion of the vehicle. APPI's repair obligation for each Protection Product applied will be limited to the lower of (a) \$2,500.00 of repair costs during the lifetime of the warranty or (b) the wholesale value of the vehicle according to the NADA Official Used Car Guide at the time of the claim (but not less than \$300). The individual Product Limited Warranty terminates whenever either of these limits is met. Advanced Protection Products International, Inc. reserves the right to rebuff and reapply Platinum Paint Protection prior to other remedies. This is the exclusive remedy and is in lieu of all remedies provided by law.

**Obligations of the Warrantor under this product Limited Warranty are insured under a reimbursement policy issued by Wesco Insurance Company, 59 Maiden Lane, 43rd Floor, New York, NY 10038. If a covered claim is not provided by the Warrantor within sixty (60) days after proof of loss has been filed, you may apply for reimbursement directly with the Insurance Company at the address above or by calling 866-505-4048.**
